University of Macau Students' Union Notice from Election Committee No. 3/2021

Announcement of Resolution by the Election Committee (1)

The Election Committee (referred to as the Committee after) announces its resolution toward facts described below, according to Article 88 of the Internal Regulation No. 1/2020 "Electoral System of Management Board" of the University of Macau Students' Union (UMSU).

On September 3, 2021, the Committee received a complaint regarding that the vice treasurer general of the UMSU, who is on suspension due to running in the election of 24th Management Board of UMSU, continued to perform duties as the vice treasurer general by arranging work related to the DSEDJ activity sponsorship in the WeChat group for financial affairs of sub-organizations. The Committee holds a hearing on September 7, 2021, and, in review of evidence, made the following resolution.

The behavior of the member on suspension is considered a violation to the regulation, but the behavior has posed no significant impact to the overall running of the election, or to the gravity of affecting the result of the election. Thus, in accordance with Article 76 of the Internal Regulation No. 1/2020 "Electoral System of Management Board", a verbal warning is issued to the member in violation.
